- I. Roll Call
 - A. Call to Order at 6:07 PM
 - B. All Present
 1. Not Present: CCO Martinez, ACO Stefanic, CEDIO Thomas, CJ Kostiuk, CoS Carfagno
- II. Bylaws
 - A. President Meis stated that the Bylaws are finished and asked if everyone could sign them.
- III. Verbal Reports
 - A. Secretary Prag stated that if anyone has any important dates to let her know to include it in her emails.
 - B. AG Barbieri stated that Speaker Drescher, CEDIO Thomas, and herself has been working on talent outreach. AcaFellas are confirmed for the State of the Student Body. Other than that, she has been working on making sure everyone knows about the attendance policies.
 - C. ACO Nelson stated that she has been working on putting out the public statements. She is hoping to have a meeting with the rest of the Communications Team to organize some things. She is going to reshare everything on social media for State of the Student Body. She is also monitoring the posts for the statements.
 - D. CFO Nelson stated that reimbursements have been sent out and is hoping to get a timeframe for it. She also stated that there needs to be an Executive Order for the Fall Banquet due to some budgeting issues from the previous years. She will also ask for a report from Business Intelligence to see how they accounted for it. CFO Noriega stated that she will also give a report on the budget at the next Senate meeting.
 1. Speaker Drescher stated that there is a lot of things on the agenda on Tuesday and would prefer if reports could be short.
 2. CFO Noriega stated that she can do the report the following week.
 - E. VP Guerrero stated that he has been working on outreach for State of the Student Body. He also had a meeting with Loyola University Public Engagement which hosts Loyola Votes to work on public engagement. Provost Search Committee is almost wrapping up and will be selecting a Provost by the end of the semester.
 - F. Speaker Drescher stated that she is finalizing guest speakers and working on organization outreach. External committees have been filled over the weekend. She stated that none of the Allocation Appeals met grounds so we will not be hearing them.
 - G. President Meis stated that they will be speaking at various organizations about organizational goals and about the State of the Student Body. She will be attending various sporting events and working with Athletics Department on how to engage with the students. A girl approached her last night about the public statement thanking her which was interesting to see that it reached the students. She also has been working with CAN to build a better relationship.
