**TUITION:** There is a minimum of four (4) credit-hours per semester to receive financial aid for the fall and spring semesters, and a minimum of two (2) credit-hours per semester to receive financial aid for the summer.

**FEES:** Includes registration fees and the CTA U-pass. The U-pass allows student's access to the CTA trains and buses while classes are in session. Summer session is not included in the CTA pass.

**MISC. FEES:** Annual Payment Plan Fee – \$105.00; Term Payment Plan Fee, per term – \$65.00; Late registration fee (non-refundable) – \$50.00; Late Payment Fee – 1.5% month.

**ROOM and BOARD:** Estimated to include reasonable rent, electric, phone and groceries for 9 months.

**TRANSPORTATION:** For students supplemental transportation needs, i.e. plane or train tickets.

**\*HEALTH INSURANCE:** This is a mandatory fee to pay for 12-months health insurance coverage (August 2009 – August 2010). **PERSONAL:** Line item that provides student with discretionary funds to cover other needs.

**TOTAL:** The total may be adjusted to accommodate the purchase of a laptop. A receipt providing proof-of-purchase date and cost will be required.

**Please note that the Cost of Attendance Budget is only an average of expenses. Many students manage to live well below the overall total which allows them to borrow much less and significantly reduce their loan debt. Debt management should be a priority for all students dependent upon loans for their education as the decisions made today can impact you 10 or more years in the future.**

**ROOMMATES:** For students who wish to have a roommate, the School of Law provides a roommate network to connect all those interested in sharing space.

**WATER TOWER CAMPUS STUDENT CENTER & RESIDENCE HALL:** There is an option to rent the rooms on an annual basis, as well per academic year. The WTC Residence Hall provides 24-hour security staff, food court with late-night café, state-of-the-art fitness center, study lounge, University Chapel, University Bookstore, outdoor terrace, and laundry room.
