
# REPORTING VIOLENCE AT LOYOLA.

## VIOLENCE IS UNACCEPTABLE AT LOYOLA

and students who use violence will be held accountable. If you have experienced sexual assault, stalking, or violence in a relationship, you have many options available to report the violence to campus authorities. Reporting is not required, but we encourage you to do so.



#### WHY CONSIDER REPORTING?

Choosing to report violence is a personal decision that only you can make. Some reasons people choose to report violence include:

- · Helping yourself recover
- · Regaining a sense of control
- · Holding the assailant responsible
- · Helping prevent violence from happening to others
- · Getting connected to support



#### IF YOU CHOOSE TO REPORT VIOLENCE AT LOYOLA,

we are committed to providing you with nonjudgmental support. If you report, we will:

- · Believe you
- Treat you with dignity and respect
- · Give you options
- Connect you to support services on or off campus



#### WHERE CAN I REPORT?

Two campus departments are responsible for holding students who use violence accountable. Both departments have been trained to respond to survivors of violence.

- Campus Safety
- Office of Student Conduct and Conflict Resolution (OSCCR)



#### TALKING TO SOMEONE IN ANOTHER DEPARTMENT.

You may also feel more comfortable talking to someone in another department who can help connect you to reporting options, such as:

- · Dean of Students
- Gannon Center
- Ministry
- · Residence Life
- · Student Activities and Greek Affairs
- · Student Diversity and Multicultural Affairs
- Wellness Center

#### **REPORTING TO CAMPUS SAFETY**

There are two ways to file a Campus Safety Report:

- · Report in person to the Campus Safety office
- Call the Campus Safety Dispatch Center



Campus Safety can help connect you to the Chicago Police Department (CPD) if you would like to pursue your options through the Illinois legal system. Campus Safety can also connect you to the on-campus conduct system through OSCCR. You can pursue one, both, or neither of these options.

When you report, the responding officer will ask if you require medical attention and gather information about the crime. If the officer determines that enough information is available, you will be asked if you want to sign a complaint, commonly known as "pressing charges". If you sign a complaint, CPD will dispatch an officer to take a report and begin investigating the crime. Campus Safety will remain in contact with you to ensure that you understand the legal process and assist you with any legal questions or concerns. You do not have to navigate Chicago's legal system on your own.



#### **REPORTING TO OSCCR**

OSCCR holds Loyola students accountable to the Community Standards outlined in the Student Handbook. There are two ways to file a report directly with OSCCR:

- Create an incident report online at LUC.edu/osccr
- · Report in person to the OSCCR office

**Upon receiving a report**, OSCCR will meet with each party involved in the incident separately and will inform you about your options. OSCCR will decide if a hearing will take place to determine responsibility of any violations of the Student Code of Conduct. Additional information about the conduct process, including hearings, appeals, and sanctions, is available in the Student Handbook.

### **YOU ARE NOT ALONE**

if you choose to report through OSCCR. Students are allowed to bring one advisor with them for support to any conduct meeting. Advisors can be Loyola faculty, staff, students, or family members. Specially trained advocates are available to help survivors of sexual assault.
