Administrative History

Loyola's School of Law was established in 1909, three years after several prominent Chicago attorneys wrote to then president Henry J. Dumbach, S.J., requesting that St. Ignatius College undertake the creation of a law school. In 1908, Rev. Dumbach wrote the Father Provincial of the Society of Jesus' Missouri Province requesting permission to establish a Law school at St. Ignatius College. The first classes were offered in the fall of 1909 at the newly formed Lincoln College of Law of Loyola University, with William Dillion, one of the attorneys who requested the establishment of the school, as dean. Arnold D. McMahon served as Secretary and Fr. Francis B. Cassilly, SJ, was Regent. In December of 1924 the Law School was admitted to membership in the Association of American Law Schools, and the American Bar Association placed Loyola on its list of approved law schools in 1925. Loyola's School of Law celebrated its centennial in 2009.

Scope and Content

The School of Law: Office of the Dean records comprise 7.5 linear feet spanning the years 1920 to 1956 and reflect the administrations of deans John V. McCormick (1927-1937) and John C. Fitzgerald (1937-1959), and secretary/assistant dean/acting dean Francis J. Rooney. The collection includes correspondence, memos, notices, reports, and class schedules. Subjects include Loyola
