
- All graduate students enrolled in 8 or more credit hours are automatically enrolled into plan with United Healthcare (<u>www.uhcsr.com/luc</u>)
- \$3,684 for Fall-start students annual coverage
- Can waive coverage through LOCUS if already covered by an insurance policy

#### **BILLING/E-BILLS**

- eBill notifications are sent on the 15<sup>th</sup> of each month
- Sent to student's @luc.edu email address and Parent/Guest access accounts
- Payments are due the 5<sup>th</sup> of the following month
- Accounts available 24/7 in LOCUS





#### **INSTALLMENT PLANS**

- Pay balance in monthly installments rather than a lump sum payment
- \$105 annual enrollment fee or \$70 term enrollment fee
- 4 and 3 month Term payment plans also available
