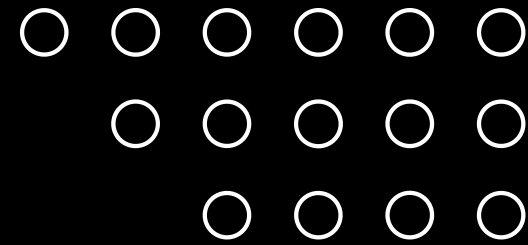

DENNERICKA BROOKS

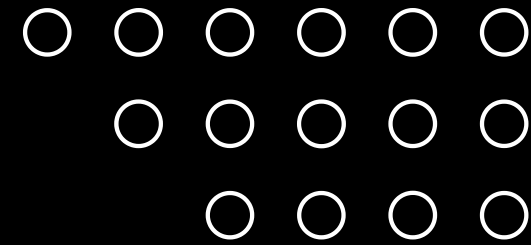

ELIZABETH RODRIGUEZ LYNCH

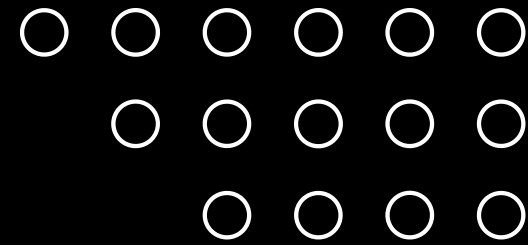

ABIGAIL MAGAT

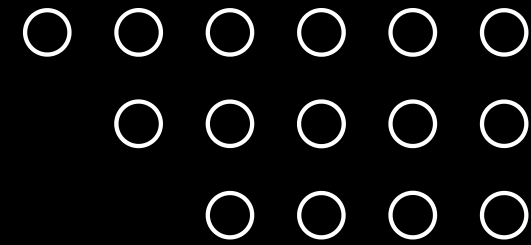
