Dear Loyola Senior:

Congratulations! You are nearing the end of your undergraduate degree program at Loyola. By submitting the Application for Graduation, you are initiating the formal review of your degree requirements. It is important that you successfully complete any courses that you may be in at this time and that you register for the appropriate courses in the future. This information sheet is a guide to help you determine your remaining degree requirements. You must carefully review your academic record with these guidelines. If you decided to withdraw your application, you must do so in writing and re-apply for a future graduation date.

The Assistant Dean of the Quinlan School of Business will review the graduation application. All courses still required for graduation will be listed. A copy of your evaluation will be e-mailed to your Loyola account provided on your application. **(You are also encouraged to make an appointment with your advisor to go over your graduation requirements after you receive your initial audit.)** In the event that mistakes are made in the initial audit, it is the student's responsibility to complete the graduation audit appointment in person to rectify any mistakes.

CHECKLIST FOR YOUR REVIEW

DEGREE REQUIREMENTS

	A minimum of 120 hours (fractions of hours are not rounded).
	Courses retaken or audited do not count toward the 120 requirement.
	A minimum of 60 hours or the final 45 hours must be taken at Loyola.
	Pass/ no pass course(s) do not count for the major, a minor or Core.
	Cumulative GPA must be 2.00 or better.
	A student must attain a minimum arithmetic GPA of no less than 2.00, i.e. "C" in the courses of each major or minor field of concentration. All attempted courses are calculated into the major/minor GPA.
	Two writing intensive courses (unless waived by the Dean because of transfer credit). Only courses designated as Writing Intensive on the schedule of classes fulfill this requirement. Writing intensive courses taken prior to completing UCWR 110 do not fulfill the WI requirement.
	If you have a grade of "I" for your final semester it is your responsibility to complete the work and have the instructor change the grade in time for your degree to be conferred.
	Grade of "C-" or better in all business core, major and minor courses, and UCWR 110. Grade of "D" or better in University Core courses (excluding UCWR 110).

TRANSFER CREDITS

	Pending transfer credits must be submitted to Loyola no later than <u>12 weeks</u> before the graduation date. Send official transcripts to Registration & Records at: Transfer Credit Processing Loyola University Chicago Office of Registration and Records 820 N Michigan Ave LT 504 Chicago, IL 60611

HONORS/ LAUDATORY STATUS

	A minimum of 60 graded Loyola hours excluding pass/no pass.
	GPA is not rounded.
	If you expect any change of grades which could affect your honors status, notify this office immediately.
	Graduation honors announced at the ceremony as based on Loyola courses and hours completed by the previous semester. Graduation honors on your transcript are based on all your Loyola work.
	Members of the Interdisciplinary Honors program should see the Director of the Honors Program regarding all degree requirements.
	Members of the Quinlan Business Honors Program should see Professor Bjorn Berg with any questions.

GRADUATION CEREMONY

Students finishing in the prior December, May or August of a particular year may participate in the **May** ceremony. Students may not choose which ceremony year they will participate in. That decision is predetermined by the Dean's Office.
