 - Reframes Paul's use of the trans-ethnic systems of thought of ancient philosophers in his rejection of gentile circumcision and his response to Corinthian ascetics alike as part of his efforts to negotiate the experience of gentile converts in a world in which ancient religion was fundamentally ancestral and conversion required serious intellectual justification.

 - o Crosses disciplinary boundaries, bringing ground-breaking ancient historical research together with psychological, philosophical, political, and theological reflection to explore the ancient social and intellectual contexts in which interpersonal forgiveness first emerged as a theological ideal in early Judaism and Christianity and critically explores the question of what theological normativity interpersonal forgiveness should claim over Christians of all denominations today from political-philosophical and theological perspectives.
