# **Biographical History**

Patricia Taylor served as the Executive Director of the North Shore Senior Center in Winnetka, Illinois. Taylor also acted as the Illinois President and the national Vice President of the Older Women's League, of which she was an active member in the Hyde Park branch.

The Older Women's League (OWL) was founded in 1980 to advocate for positive changes in the economic, physical, and social environments in which midlife and older women live. This included policy advocacy and production of educational material. This educational material was used by its members and chapters to testify before Congress and other governmental agencies on issues related to midlife and older women. The national Older Women's League organization dissolved in 2017, and the Hyde Park OWL branch had their last meeting in 2019.

# **Scope and Content**

The donation is comprised of newsletters, brochures, news clippings, meeting minutes, financial reports, correspondence, notes, awards, and two DVDs. Most of the materials pertain to the Older Women's League (OWL), both the national and Illinois chapters, and concern topics such

as menopause, health, pensions, income security, social security, and general aging. Other subjects represented include the Senior Center of Palo Alto, the North Shore Senior Center, the Illinois Conference on Aging, and the Illinois Women's Health Coalition.
